YMCA 24-HOUR FITNESS CENTER ACCESS

Door County YMCA

We know you're constantly on the go. That's why the Door County YMCA is pleased to offer our adult members ages 18+ with convenient 24 hour per day, 7 days per week, year-round access to our YMCA fitness center.

How To Apply For 24/7 Access

Adult YMCA members ages 18+ may apply for 24/7 fitness center access at our member services desk. This benefit is **ONLY** for adult members of the Door County YMCA. Individuals with a day pass, one month membership, AWAY members, Nationwide members & other short-term memberships/visiting guests are unable to apply for access. The YMCA will notify you if your access is approved, and your key fob will be activated. This process typically takes 1-3 days. Should access be denied, you may return your key fob to the YMCA for a full refund.

Safety & Security

Our YMCA 24/7 fitness center is protected by our advanced security & video surveillance system. Note that this system does not provide staffing assistance for emergencies that might arise. As such, we highly recommend that you exercise with another 24/7 member when using our facility outside of staffed hours. Red telephones are located in the main hallway and in the fitness center. There is an AED by the front desk. In case of emergency, please dial 911. For your safety, some parking lot lights will remain on after the Y closes. Please park in the lit area. Snow removal will not be enforced until staffed hours, possibly later due to certain weather conditions. During inclement weather, you may still access the facility after hours but at your own risk from the elements.

Honor Code

The Y has a strict 24/7 honor code based on Y values of honesty, respect, caring, and responsibility. These guidelines are in place for the safety and security of our members, and the protection of our property. If a Y member fails to abide by these policies, their 24/7 access and potentially their membership will be revoked with no refunds given.



APPLY TODAY FOR YMCA 24/7 ACCESS

The Y Fits Your Busy Lifestyle!

Adult members of the Door County YMCA who are ages 18+ are welcome to apply for 24/7 fitness center access at the YMCA member services desk. To apply for access, you must sign a 24/7 access waiver and agree to abide by our policies, pass a background check, and purchase a \$25 key fob.

24/7 members are welcome to use the YMCA Fitness Center any time day or night, but there will be no staff available to assist members during non-staffed hours. Please see our website, DoorCountyYMCA.org, to view current staffed building hours.

Key Fobs

Your key fob is your after-hours key to the fitness center and is unique to your membership will allow access as long as your membership remains current. Should you lose or damage your fob, report it to the Y immediately. A replacement can be purchased for \$15. To access the fitness center, hold your key fob up to the fob reader. You will hear the door activate and see the reader light turn from red to green. Pull on the door to gain access (there is a 5 second time limit). When entering and exiting the Fitness Center, please ensure the door closes behind you. Do not hold the door for anyone, as they will need to use their own key fob for access. This is so we can track who is in the building at all times. Key fobs may not be shared with others (including family), and members are not allowed to grant facility access to anyone else. Doing so is a violation of our policy and will result in you permanently losing your 24-hour access to the Y and a possible termination of your Y membership.

Door County YMCA 24/7 Facility Agreement, Waiver and Release Form
Initial each line marking acceptance

Use of the Door County Y (DCY) facility outside of staffed hours of operation is for DCY members only. Members must be at least 18 years of age, have passed a criminal background check, have purchased a key fob, and must use their assigned key fob to gain entrance. Family members on my membership cannot use my 24/7 access, even if I am present. I understand if my key fob is used to let anyone in I will lose my 24/7 access permanently and possibly lose my DCY membership.

The DCY will conduct an extensive criminal background check (examples may include: theft/or violent acts) using the information I provide. The results of the background check are strictly confidential. I understand that should my background check not meet the stringent requirements of having 24/7 access, I understand that my key fob will be deactivated, and I am entitled to a refund of fees paid. I understand I will receive email notification of when my access is available or revoked.

The DCY HIGHLY recommends that you have an adult workout partner, who has a 24/7 membership with the DCY, accompany you while using the DCY 24/7 facility (unauthorized personal training is not allowed and will result in termination of 24/7 access). You have agreed to purchase a membership key fob which will allow you access to the DCY facility outside of staffed hours of operation. As such, you are aware that there will be no staff or assistance when using the facility(s) outside of the regularly staffed hours of operation. You are also aware that should you become injured, unconscious, suffer a stroke or heart attack, that there will likely be no one to respond to your emergency and this facility has no duty to provide assistance to you.

Physical exercise can be strenuous and subject to risk of serious injury. The DCY urges you to obtain a physical examination from a doctor before using any exercise equipment or participating in any exercise activity. You agree that if you engage in physical exercise or activity, or use any DCY amenity on the premises, you do so entirely at your own risk. You agree that you are voluntarily participating in the use of this facility and assume all risks of injury, illness, or death. The DCY is also not responsible for any loss of or damage to your personal property.

This agreement includes, without limitation, all injuries which may occur, regardless of negligence, as a result of; a) your use of the allowed amenities (gym space, free weight room, lifestyle center only) and equipment in the facility and your participation in any activity, b) the sudden and unforeseen malfunctioning of any equipment, c) you slipping and/or falling while on the DCY premises, including adjacent sidewalks and parking areas. I understand that the following areas/amenities are not available outside of regular business hours: locker rooms, SB track, classroom spaces, pool, and personal training.

Snow removal will not be available outside of regularly scheduled hours. Members with 24/7 access can utilize the DCY but do so at their own risk from the elements.

Under sole discretion of the DCY, my 24/7 access may not be granted or may be revoked at any time (ex: membership is on hold, or NSF for membership fees)

I understand and acknowledge that unauthorized use of video or photos is strictly prohibited.

You acknowledge that you have carefully read this agreement and fully understand that it is a release of liability. You expressly agree to release and discharge the DCY and all affiliates, employees, agents, representatives, successors, or assigns, from any and all claims or causes of action. You agree to voluntarily give up or waive any right that you may otherwise have to bring a legal action against the DCY for negligence, personal injury or property damage.

Note: Should any part of this agreement be found by a court of law to be against public policy or in violation of any state statute or case precedence, then only that wording is removed, and the remainder of this agreement will remain in full force. By signing below, I give the Door County YMCA (DCY) permission to conduct a criminal background check on me.
